Walter Reed Society Assists Wounded Warriors, Families

Usually, when a person returns from a long stay away from home, the homecoming is a joyous occasion. However, thousands of servicemembers and their families quickly realize the pain and tough road ahead once the servicemember has settled in.

Since the wars in Iraq and Afghanistan began more than a decade ago, approximately 2.3 million servicemembers have served in those wars. As with any war, casualties and fatalities are the ultimate sacrifices made. Due to advances in combat medicine and body armor equipment, more warriors are returning home alive. For many, this is when the real struggle begins. Thousands of wounded warriors find it difficult to acclimate back into their families while trying to deal with the invisible wounds they suffered while deployed, post-traumatic stress disorder (PTSD). The Veterans Administration has reported treating more than 210,000 servicemembers for PTSD and states there are many more who have not been treated due to the stigma associated with the diagnosis.

Getting their lives back on track can often be a struggle for both the servicemember and their family so the Walter Reed Society steps in to assist whenever and however it can. In 2004, the WRS established a fund to assist servicemembers being treated at Walter Reed Army Medical Center. The fund was created with the support of corporate and private donors and is titled the WRS Warrior/Family Support Fund. During this short period, the Society has granted more than \$2 million toward assisting servicemembers and/or their families. Since the merger with the National Naval Medical Center in September 2011, the WRS has granted more than \$83,000 to servicemembers and/or their families.

None of this support would be possible without the generous donations made by several organizations and individuals over the past few years. These donations have allowed the WRS to assist with things such as airfare, childcare expenses, clothing, physical therapy, funeral expenses, lodging expenses, mortgage/rent payments, and a list of others. The WRS is thankful to be able to give back and assist wounded warriors and their families who have made the in any way possible and that support will continue with the help of our generous donors.

Plans for Walter Reed Hospital

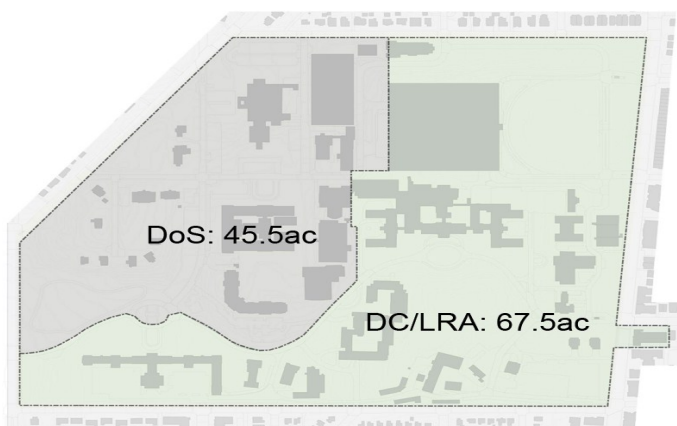

Since the merger of Walter Reed Army Medical Center (WRAMC) and the National Naval Medical Center, many maybe wondering what are the plans for WRAMC. As I understand it, the Local Redevelopment Authority (LRA) charged with developing a plan for use of WRAMC campus has submitted their plan to the D.C. Council. The Council must approve the plan before it goes to the federal Department of Housing and Urban Development.

The plan covers only about 68 acres of the campus with the remaining 45 acres going to the Department of State, whose plans are yet unannounced. The LRA plan calls for 3.1 million gross square feet of development, of which over half will be residential, a quarter office space, and the rest retail and "creative" space. Two D.C. public charter schools will get a combined 130,000 square feet. There will be 40 units of housing for homeless seniors, 75 units of low-income housing, and the Transitional Housing Corpo-

ration will get 6,000 square feet of office space.

Also, just as important, according to specific language in the plan there will be no bus maintenance or storage facilities as some had pushed. It is my understanding that buildings built before 1955 will be preserved.



The figure layout is oriented to the north with Georgia Ave to the right and 16th Street to the left. The darker areas are the current buildings. DoS will be Department of State property and LRA will be property conveyed to the city. Conveyance could take 1-2 years.

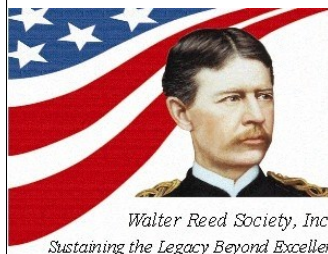
